1. Cases which cannot be fixed before DB-I, will be fixed before DB-II and vice versa and case which cannot be fixed before DB-I and DB-II will be fixed before remaining member of DB with senior member of S.B.
2. Case under various Act. Contempt of Court cases received from the Sub-Ordinate Courts. Application for early hearing of cases. Bail before arrest applications and matters relating to transfer of cases will be fixed before the Honourable Chief Justice and his absence, at principal seat Karachi will be fixed before another senior most Judge.
3. Case which cannot be fixed before S.B-I-(AS) will be fixed before SB-II(AS) and vice versa and those cases which cannot be fixed before S.B-I and S.B-II will be fixed before S.B-I (O.S).and etc.
4. Cases which cannot be fixed before SB-I(OS) will be fixed before SB-II(OS) and vice versa and those cases which cannot be fixed before SB-I (OS) and SB-II (OS) will be fixed before SB-I (A.S) and etc..
5. Commercial Cases will be given priority over other matters.
6. Cases of Special Appellate Court (Customs & Taxation) will be fixed before Hon'ble Chief Justice and in his absence, at principal seat Karachi will be fixed before another senior most Judge SB appellate side.
