

## HIGH COURT OF SINDH KARACHI

No. 660/Conf:VI-Z-23(328)DP

### O R D E R

*WHEREAS*, the Show Cause Notices bearing No.727/Conf:VI-Z-23(Report), dated 31<sup>st</sup> July, 2009 and No. 480/Conf:VI-Z-23(328-DP) dated 17<sup>th</sup> June, 2013 under the provisions of Sindh Civil Servants (Efficiency & Discipline) Rules, 1973 on the ground of 'corruption' were served upon Mr. Ali Gul Khaskheli, Civil Judge & Judicial Magistrate, replies thereof were furnished by the delinquent Officer on 13<sup>th</sup> August, 2009 and 7<sup>th</sup> October, 2013, respectively.

*AND WHEREAS*, the Authorised Officer after affording an opportunity of personal hearing to the delinquent Officer and perusing the record, had come to the conclusion that he is guilty of charge leveled against him and liable to impose major penalty of '**dismissal from service**' prescribed under Rule 4(1)(b)(iv) of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973, upon him. As such Final Show Cause Notice bearing No. 409/Conf:VI-Z-23 (328)DP, dated 2<sup>nd</sup> May, 2015 was served upon him, reply thereof was furnished by him on 21<sup>st</sup> May, 2015.


*AND WHEREAS*, the Hon'ble Authorised Officer, while going through the facts as well as circumstances of the matter and giving an opportunity of personal hearing to the delinquent Officer, has come to the conclusion that the delinquent Officer is guilty of the charge leveled against him and recommended that the major penalty of '**dismissal from service**' as prescribed under Rule 4(1)(b)(iv) of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973, be imposed upon him.

*AND WHEREAS*, the Hon'ble Chief Justice/Authority, after considering the facts as well as circumstances of the matter and hearing the delinquent Officer in person has decided, in exercise of powers under clause (b) of Sub-Rule (4) of Rule 5 of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973, to impose major penalty of '**dismissal from service**' as prescribed under Rule 4(1)(b)(iv) of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973, upon Mr. Ali Gul Khaskheli, Civil Judge & Judicial Magistrate.

**NOW THEREFORE**, the penalty of 'dismissal from service' as prescribed under Rule 4(1)(b)(iv) of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973 is hereby imposed on Mr. Ali Gul Khaskheli, Civil Judge & Judicial Magistrate, with immediate effect.


