TERMS AND CONDITIONS

1. **Auction / Bidding documents** can be downloaded from official website of the High Court of Sindh, Karachi free of cost.
2. Interested parties may examine the unserviceable items on any working day between **09:00 a.m. to 1:30 p.m.** at the designated premises of the High Court of Sindh, Karachi, up to **14.02.2026**.
3. Genuine bids/offers shall be submitted separately along with **Bid Security** in the form of Call Deposit / Pay Order / Demand Draft / Bank Guarantee issued by a scheduled bank of Pakistan, being **10% of the total bid value**, in favour of the **Registrar, High Court of Sindh, Karachi**. The bids must be submitted in sealed envelopes and should reach or be dropped in the tender box placed at the office of the undersigned by **10:30 a.m. on Monday, March 16, 2026**. Bids received without the required bid security or after the stipulated date and time shall not be accepted or entertained.
4. The bids shall be opened at **11:00 a.m. on Monday, March 16, 2026**, in the office of the undersigned in the presence of the bidders or their authorized representatives. In case of any unforeseen situation or government holiday resulting in closure of the office on the date of opening, the bids shall be submitted/opened on the next working day at the same time and venue.
5. The successful bidder shall be liable to pay applicable **withholding tax and other government taxes**, in addition to the bid amount.
6. The unserviceable stores/material shall be handed over to the successful bidder only after approval of the competent authority and upon receipt of full payment.
7. The Procuring Agency reserves the right to **reject any or all bids** in accordance with applicable procurement rules. The Authority also reserves the right to negotiate with the three highest bidders or all bidders, if deemed necessary, to obtain the best price for the store.
8. The successful bidder shall deposit **10% of the total bid value on the same day of approval**, and the remaining amount shall be deposited within **seven (7) calendar days** from the issuance of the award/order. In case of failure to deposit the full amount within the stipulated period, the bid security shall be forfeited.
9. The Bid Security shall be released after complete clearance of the site, as certified by the Auction Committee.
10. The successful bidder shall lift all material within **ten (10) days** from the date of approval/order and shall be responsible for cleaning the premises where the material is stored.
11. Employees of the High Court of Sindh, Karachi, or their close relatives are **not eligible** to participate in the auction.
