O R D E R

WHEREAS, the Show Cause Notice bearing No.1420/Conf:VI-Z-23(454) dated 10-11-2015 was served upon Mr. Qadir Bux Dahri, Additional District & Sessions Judge, Ghotki under the provisions of Sindh Civil Servants (Efficiency & Discipline) Rules, 1973, and reply thereof was furnished by him on 2-12-2015.

AND WHEREAS, the Hon'ble Authorised Officer after giving an opportunity of personal hearing to the delinquent officer and perusing the record has recommended that the minor penalty of Censure prescribed in Rule 4(1)(a)(i) of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973 be imposed upon him. As such, a Final Show Cause Notice bearing No. 750/Conf: VI-Z-23(454) dated 26-06-2016 was served upon him and reply thereof was furnished by him on 28-07-2016.

AND WHEREAS, the Hon'ble Authorised Officer, after affording an opportunity of personal hearing to the delinquent officer on 26-8-2016 and considering the facts of the matter, in exercise of powers conferred upon him under clause (a) of Sub-Rule (4) of Rule 5 of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973 has decided to impose minor penalty of '**Censure**' prescribed in Rule 4(1)(a)(i) of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973 upon him.

NOW THEREFORE, the penalty of '**Censure**' prescribed in Rule 4(1)(a)(i) of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973 is hereby imposed upon Mr. Qadir Bux Dahri, Additional District & Sessions Judge.


