

**Important Note:**

As per policy of Pakistan Medical and Dental Council;

1. No candidate will be eligible for admission until and unless he has appeared in the entry test of respective province.
2. The test carries 50% weightage in preparation of Merit.
3. The Islamic International Medical college will not conduct any entrance test this year. Entrance test of all provinces is acceptable. Kindly submit the application along with copy of result of entry test.
