

HIGH COURT OF SINDH KARACHI

No.217/Conf:VI-Z-23(65-JM)DP Karachi, dated: February 22, 2016

O R D E R

WHEREAS, the Show Cause Notice bearing No.474/Conf:VI-Z-23(65-JM)-DP, dated 17th June, 2013 was served upon Mrs. Erum Jahangir, Civil Judge & Judicial Magistrate, under the provisions of Sindh Civil Servants (Efficiency & Discipline) Rules, 1973, on the ground of "*in-efficiency*" and "*corruption*" reply thereof was furnished by her on 31.7.2013.

AND WHEREAS, the Hon'ble Authorised Officer after affording an opportunity of personal hearing to the delinquent Officer and perusing the record, had come to the conclusion that she is guilty of charge leveled against her and liable to impose major penalty of '*dismissal from service*' as prescribed under Rule 4(1)(b)(iv) of Sindh Civil Servants (Efficiency & Discipline) Rules, 1973. As such Final Show Cause Notice bearing No.857/Conf:VI-Z-23(65-JM)DP, dated 9th September, 2015 was served upon her, reply thereof was furnished by her on 20.10.2015. However, after hearing the delinquent officer, the above mentioned major penalty was recommended.


AND WHEREAS, the Hon'ble Chief Justice/Authority, after considering the facts and circumstance of the matter and hearing the delinquent Officer in person on 6.2.2016, while exercising the power vouchsafed under clause (b) of Sub-Rule (4) of Rule 5 of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973, has decided and order to impose major penalty of '*Compulsory Retirement*' as prescribed under Rule 4(1)(b)(ii) of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973, upon Mrs. Erum Jahangir, Civil Judge & Judicial Magistrate.
