O R D E R

WHEREAS, the Charge Sheet as well as Statement of Allegation bearing No.273/RHC/Conf:VI-Z-23(338) dated 15.3.2003 was served upon Mr. Muhammad Sharif Buriro, Senior Civil Judge under Rule 6 (1) of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973 on the grounds of “**misconduct**” and “**corruption**” and reply thereof was furnished by him.

AND WHEREAS, looking into the allegations, an inquiry was ordered to be conducted through an Inquiry Officer. The Hon'ble Inquiry Officer after conducting the inquiry, reported that the charges against the delinquent Officer stand fully proved. As such, a Final Show Cause Notice bearing No./Conf: VI-Z-23(338) dated 19.02.2009 was served upon him and reply thereof was furnished by him on 06.04.2009.

AND WHEREAS, the Hon'ble Authorised Officer, after considering the reply to Final Show Cause Notice, affording an opportunity of personal hearing to the delinquent Officer and going through the facts of the matter, has come to the conclusion that he is guilty of the charges leveled against him and recommended for imposition of major penalty of ‘**dismissal from service**’, prescribed in Rule 4(1)(b)(iv) of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973, upon him.

AND WHEREAS, the Hon'ble Chief Justice/Authority, after considering the facts of the matter, providing an opportunity of personal hearing to the delinquent Officer and keeping in view his length of service, has converted the major penalty of ‘**dismissal from service**’ into ‘**compulsory retirement**’, in exercise of the powers conferred upon him under Rule 5(4)(b) of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973.

NOW THEREFORE, the penalty of '**compulsory retirement**' under Rule 4(1)(b)(ii) of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973 is hereby imposed upon Mr. Muhammad Sharif Buriro, Senior Civil Judge, with immediate effect.
