ORDER

WHEREAS, on the Report dated 15.6.2016 of the Registrar, the Hon'ble Chief Justice/Appointing Authority had ordered to initiate the fact finding inquiry against M/s. Atir Mehmood and Humayun Zeb, the then Incharge Project Directors (AJP) of this Court in the matter of awarding contract for procurement of furniture for the 58 newly created courts, the Hon'ble Chief Justice has been pleased to appoint an Enquiry Officer as prescribed in Rule 13, Sub-rule (3) clause (b) to hold a detailed fact-finding enquiry, fix responsibility and recommend penal action against the persons found at fault.

AND WHEREAS, the Hon'ble Enquiry Officer after conducting enquiry concluded that the charges levelled against the delinquent Officers stand fully proved and recommended the major penalty of dismissal from service as prescribed in clause (g) sub rule (2) of rule 13 of the Sindh High Court Establishment (Appointment & Conditions of Service) Rules, 2006. As such a Show Cause Notice bearing No. HC/GAZE/01796 dated 2.12.2016 under Rule 13 of the Sindh High Court Establishment (Appointment & Conditions of Service) Rules, 2006 on the grounds of "corruption & misconduct" was served upon Mr. Humayun Zeb, Secretary, Protocol-II of this Court and reply thereof was furnished by him on 26.12.2016.

AND WHEREAS, the Hon'ble Chief Justice/Appointing Authority after considering the reply to Show Cause Notice, facts of the matter and providing an opportunity of personal hearing to the delinquent officer in respect of Show Cause Notice dated 2.12.2016, in exercise of powers under clause (2) sub Rule (3) of Rule 13 of the Sindh High Court Establishment (Appointment & Conditions of Service) Rules, 2006, has decided to impose major penalty of 'dismissal from service' prescribed in clause (g) sub Rule (2) of Rule 13 of the Sindh High Court Establishment (Appointment & Conditions of Service) Rules, 2006 upon Mr. Humayun Zeb, Secretary Protocol-II of this Court.

Now THEREFORE, the penalty of 'dismissal from service' prescribed in clause (g) sub Rule (2) of Rule 13 of the Sindh High Count Establishment (Appointment & Conditions of Service) Rules, 2006 is hereby imposed upon Mr. Humayun Zeb, Secretary Protocol-II of this Court with immediate effect.
