O R D E R

WHEREAS, the Show Cause Notice bearing No. 812/Conf:VI-Z-23(372) dated 23.6.2010 was served upon Mian Fayyaz Rabbani, Senior Civil Judge under the provisions of Sindh Civil Servants (Efficiency & Discipline) Rules, 1973 on the ground of "**Corruption**" and reply thereof was furnished by him on 07.07.2010.

AND WHEREAS, the Hon'ble Authorised Officer after affording an opportunity of personal hearing to the delinquent Officer and perusing the record, has come to the conclusion that the delinquent Officer is liable to be imposed major penalty of '**dismissal from service**' prescribed in Rule 4(1)(b)(iv) of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973. As such, a Final Show Cause Notice bearing No. 333/Conf: VI-Z-23(372) dated 18.03.2016 was served upon him and reply thereof was furnished by him on 24.05.2016.

AND WHEREAS, the Hon'ble Authorised Officer, while affording an opportunity of personal hearing to the delinquent Officer and going through the facts of the matter, has come to the conclusion that he is guilty of the charge levelled against him and recommended for imposition of major penalty of '**dismissal from service**', upon him.

AND WHEREAS, the Hon'ble Chief Justice/Authority, after considering the facts of the matter and providing an opportunity of personal hearing to the delinquent Officer, in exercise of the powers under Rule 5 (4) (b) of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973, has decided to impose major penalty of '**dismissal from service**', upon him.

NOW THEREFORE, the penalty of 'dismissal from service', under Rule 4(1)(b)(iv) of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973 is hereby imposed upon Mian Fayyaz Rabbani, Senior Civil Judge, with immediate effect.
