1. SCOPE OF WORK / ITEM DESCRIPTION

Supply of uniforms and footwear for **30 Chowkidars** of the High Court of Sindh, Karachi, comprising:

- Two (02) sets of stitched **Shalwar Kameez** (wash & wear fabric of acceptable quality, locally available reputed brand or equivalent) per chowkidar
- One (01) pair of **Peshawari Chappal (Soft & Pure Leather)** per chowkidar, of standard commercial quality, comfortable fit, and durable sole
- Light, breathable and comfortable fabric suitable for summer season
- Each uniform set shall include **badges and monograms** as per specification/instructions of the High Court of Sindh
- Proper stitching, finishing, and standard fitting for staff uniforms
- Complete delivery of finished uniform sets and footwear in ready-to-wear/ready-to-use condition

Bidders shall match the general design, cut, and finishing shown here, subject to the fabric, colour, and badge/monogram specifications of the High Court of Sindh.

- Quality of cloth/fabric and leather (sample evaluation)
- Workmanship and stitching quality
- Cost-effectiveness within budget ceiling
- Compliance with specifications provided by the High Court of Sindh
