- Supply and installation of Goose Neck Microphones — HTDZ HT-32 PRO Meeting/Conference type, desktop standing, flexible gooseneck, dynamic mic with 10M cable, or equivalent standard.
- Supply and installation of Amplifier — TOA 2120, 120 Watt, or equivalent standard.
- Supply and installation of Speaker — TOA BS-1030, Wall Mounted, 30 Watt, or equivalent standard.
- All wiring, cabling, connectors, mounting hardware, and accessories required for a complete, fully functional installation shall be included in the vendor's scope, at no extra cost.
- The system shall be installed, tested, and commissioned to the satisfaction of the High Court of Sindh, with clear and balanced audio output throughout the Court Room.
- Bidders may propose reputed equivalent brands of comparable or better specification; the Procuring Agency reserves the right to verify equivalence.
