- a) The District & Sessions Judges are entitled to (15) days' vacations.
- b) The Additional District & Sessions Judges who have earned the required units are entitled (15) days' vacations. The Additional District & Sessions Judges who have not earned the required units are allowed to avail (10) days summer vacations, as a special case.
- c) The Additional District & Sessions Judges, Senior Civil Judges and Civil Judges/Judicial Magistrates who have less than one year service are not entitled to any vacations.
- d) The Senior Civil Judges and Civil Judges/Judicial Magistrates who have earned the required units are entitled to vacations for two weeks. Those Senior Civil Judges and Civil Judges / Judicial Magistrates who have not earned the required units are entitled to (10) days summer vacations, as a special case.
