
1. For use of EPADS, unregistered bidders may first register on the website <https://sindh.eprocure.gov.pk/>. In case of any technical difficulty in registration or use of EPADS, prospective bidders may contact SPPRA's Technical Support Team.
2. The e-bidding documents, as per applicable regulations and containing detailed terms and conditions, specifications, and requirements, are available to registered bidders on EPADS at <https://sindh.eprocure.gov.pk/> and official website of Sindh High Court.
3. In terms of Rule 37(2) of the Sindh Public Procurement Rules, 2010, all bids must be accompanied by a Bid Security equivalent to 5% of the total bid value in the shape of Deposit at Call, Pay Order, Demand Draft, Call Deposit Receipt (CDR), or Bank Guarantee issued by a scheduled bank in Pakistan, in favour of the Registrar, High Court of Sindh, Karachi. Prospective bidders shall upload a scanned copy of the Bid Security on EPADS along with the electronic bid submission. However, the original hard copy of the Bid Security, along with the hard copy of the bid, must also be submitted within the prescribed date and time.
4. The bidding shall be conducted in accordance with the **Single Stage – Two Envelope Procedure, Sindh Public Procurement Rules, 2010**, accordance with Rule 46(2) of Sindh Public Procurement Rules, 2010 (Amended).
