## 1. INTRODUCTION

## 3. FINANCIAL BID OPENING

The financial bids of the technically qualified bidders were opened on the scheduled date in the presence of the bidders / authorized representatives.

The bid prices quoted by the participating bidders are as follows:

#### 4. FINANCIAL EVALUATION & COMPARISON

Upon examination of the financial bids, it was observed that:

- All bidders quoted rates in accordance with the prescribed format.
- No arithmetic errors / conditional deviations materially affecting price comparison were observed.
- Bid prices were compared on the basis of **total evaluated cost**.

#### 5. DETERMINATION OF LOWEST EVALUATED BID (L1)

Based on the comparative analysis of quoted prices:

- M/s Sanitrol Enterprises has emerged as the **Lowest Evaluated Bidder (L1)** with a bid price of:



## 6. CONCLUSION
