## 1. INTRODUCTION

This Technical Bid Evaluation Report has been prepared in respect of the tender titled “**Extension and Enhancement of Security and Surveillance System at the High Court of Sindh, Circuit Court, Hyderabad**”. The evaluation was carried out in accordance with the approved bidding documents, applicable procurement rules, and relevant provisions of **SPPRA Rules**. The objective of this evaluation was to assess the **technical responsiveness, compliance, and capability** of participating bidders with respect to mandatory eligibility requirements and technical specifications prescribed in the tender documents, prior to opening of the financial bids.

## 2. BIDDERS PARTICIPATED

The following firms submitted their technical bids within the stipulated time:

2. M/s M.A. Tech
3. M/s Sindh Computers
4. M/s Sanitrol Enterprises

## 3. EVALUATION METHODOLOGY

The technical evaluation was conducted in two Parts:

- **Part I – Mandatory Qualification / Eligibility Criteria**
- **Part II – Detailed Technical Compliance against Required Specifications**

Each bid was examined for **documentary completeness, regulatory compliance, and technical conformity**. Only those bidders meeting **100% mandatory requirements** were considered technically responsive.



## 4. MANDATORY QUALIFICATION / ELIGIBILITY (PART-I)

All participating bidders were evaluated against the mandatory eligibility criteria;

Accordingly, **no bidder stands technically disqualified** at this stage.




