





### **1. UPLOADING OF TENDER NOTICE & TENDER DOCUMENT:-**

Tender Notice and tender document for procurement of Poly Cloth for holding files were uploaded on the Official website of Sindh High Court and SPPRA on 7<sup>th</sup> June, 2022 but no bidder participated in the tender. Re-tender notice and tender document were uploaded on 23<sup>rd</sup> August, 2022 on the relevant website but again no bidder participated in the subject tender.

Third time tender notice and tender document were uploaded on 23<sup>rd</sup> September, 2022 and this time two (02) bidders participated in the tender as reflected in attendance sheet.

### **2. TENDER OPENING:-**

No objection was received on tender documents, eligibility criteria, specifications, terms and conditions from any corner. M/s. I. S Enterprises and M/s. Zobi Traders submitted sealed tender documents. Tender was opened in public on 21<sup>st</sup> November, 2022 at 11:00 a.m., in the presence of Chairman, Members of Procurement Committee and representatives of bidders.

### **3. EVALUATION OF ELIGIBILITY CRITERIA:-**

All bids were evaluated on the basis of already defined eligibility criteria which were based on specified parameters as mentioned below:-


Both the above named bidders could not qualify the eligibility criteria. Hence, their bids cannot be considered for further evaluation as per rules.
