6. Terms & Conditions

- 1. <u>Bidding Method:</u> Single Stage- Two Envelope method will be adopted for bidding process as per SPPRA Rules.
- 2. <u>Company Profile:</u> Company Profile along with relevant documents be attached with this document.
- 3. <u>Issuance of Purchase Order:</u> Purchase Order shall be issued from Assistant Data processing Officer (ADPO), IT Department, Sindh High Court Karachi.
- Bid Security: All bids must be accompanied by an earnest money/ security of 1% of total bid amount. The bid security of unsuccessful bidder will be released by SHC after award of work or after expiry of bid validity period as per rules.
- 5. <u>Performance Security</u>: Bidders must submit performance security equals to 3% at the time of receiving of purchase order. The bid security of successful bidder will be released after submission of Performance Security equal to 3% of total cost of contract.
- 6. <u>Release of Performance Security</u>: Performance Security shall be released after successful delivery of goods and issuance of satisfactory certificate from the concerned officer.
- 7. <u>Validity Period</u>: The procurement contract will be awarded within bid validity period i.e. 90 days as per SPRRA Rules.
- 8. <u>Receiving/Acceptance of Purchase Order</u>: The vendor will sign the copy of the Purchase Order as acknowledgement.
- 9. <u>**Time of Delivery of Good:**</u> The delivery should be made by the supplier at the residences of the Hon'ble Judges as per purchase order.
- 10. **Inspection:** Physical inspection will be carried out by SHC. Ordered material is subject to final inspection at the time of delivery.
- 11. **Quantity Delivered:** Competent Authority reserves the right to increase/decrease the quantity as per requirement and availability of funds, as per rules.
- 12. <u>Condition of Goods</u>: All items must meet in all respects with the specifications & conditions of the Order and must be in good condition & conform to the best industrial quality standards; otherwise they will be liable to be rejected as per rules.

- 13. <u>Rejection of Goods</u>: Sindh High Court reserves the right to cancel any or all the items if material is not in accordance with required specification or if the delivery is delayed.
- 14. **Disclosure of Confidential Script/Material:** All rights reserve with the SHC and no information either in written/electronic media/copying form should be disseminated without the permission of the authority.
- 15. <u>Submission of Bills/Invoices</u>: Invoice/bill, Purchase Order & Delivery Challan should be submitted at Sindh High Court after successful installation of the equipment.
- 16. <u>Price / Rate</u>: Price/ rate shall include all taxes, duties, levies, charges, insurance, freight, transportation etc. All currency in the proposal shall be quoted in Pakistani Rupees (PKR). The Bid prices and rates are fixed during contract and under no circumstance shall any contractor be entitled to claim enhanced rates for any item in this contract.
- 17. **<u>Resolution of Differences</u>**: In case of any difference or dispute arises between the parties, the same shall be dealt with as per rules.
- 18. **<u>Rules, Regulations & Policies</u>**: All rules, regulations and policies will be governed in accordance to the SPPRA.
- 19. <u>General Sales Tax</u>: General Sales Tax will be paid on applicable items only by the company/firm/agency.
- 20. <u>Rights</u>: SHC reserve the right to accept or reject any or all tender(s) or terminate proceedings at any stage in accordance to the rules & regulations framed by SPPRA.
- 21. <u>Mistakes in Calculation:</u> The contractor/ supplier will be liable for any mistakes in calculation of price/ rate and amount and shall be liable to suffer the loss arises at any stage of contract, due to mistakes in calculation or tax rates.
- 22. <u>Government tax (es), levi(es) and charges(s)</u>: All Government taxes (including Income tax and stamp duty), levies and charges will be charged as per rules. Bidder should keep them updated regarding taxation issues in consultation with the relevant tax regulatory authorities.
- 23. <u>Stamp Duty</u>: Stamp duty will be levied as per rules. All matters of stamp duty shall be dealt with by the budget branch and A.G Sindh.
- 24. <u>Alternative Bids</u>: Alternative bids shall not be considered and complete tender shall be rejected being non-responsive.
- 25. <u>Interest on Late Payments</u>: No interest shall be paid on late payment if cheque is received late from the Office of A.G Sindh. However, every effort shall be made for timely payments to successful bidders.
- 26. **Dismantling of old Analog Based CCTV System at 5 Locations**: Five analog CCTV systems (four in Karachi and one in Mirpurkhas) will be dismantled and replaced with five new IP-based CCTV systems, and the equipment removed from all five locations will be delivered to the IT Department, Sindh High Court, Karachi. This activity is considered to be the part of the tender and no extra charges will be paid to the successful bidder in this regard.
- 27. <u>Warranty</u>: After successful installation of all above items the Warranty with services and troubleshooting for all above mentioned items must be 1 Year including power-supplies, adaptors, UPS-batteries etc.
- 28. <u>Termination of Contract</u>: SHC may terminate the contract, if the successful bidder fails to supply all or parts of goods within definite time or fails to perform any other obligations of contract or bidder has failed to submit performance security or bidder has involved in fraud/ corruption.
