


**Remarks:-**

1. M/s. Gresham's submitted letter on 18-03- 2020 (2 days prior to opening of tender) that tender process may be extended up to one month as its Principal Yanmar has informed that the said company has shut down its operation in Japan due to increasing number of COVID-19 cases. No documentary proof was attached with the said letter.
2. M/s. Gresham's submitted another letter dated 19-03-2020 (1 day prior to opening of tender) requesting therein that tender documents may be revised. It was clearly mentioned in tender document that request for clarification & modification of the same may be sent to Procurement Committee at least five (05) calendar days prior to date of opening. Hence, the said request for modification of tender document cannot be considered as per rules.
3. M/s. Gresham's did not participate in tender process so that it can be ascertained whether it is eligible to participate in the instant tender or otherwise. Request of M/s. Gresham's cannot be considered as sufficient numbers of bidder have participated in the instant tender despite the same situation of corona virus. Hence, the said tender cannot be extended on the request of only bidder who did not even care to submit bid.
4. Objection (s) if any along with documentary proof should be submitted within THREE (03) calendar days of uploading of report. Thereafter, no objection shall be considered.
