C I R C U L A R

The Honourable Chief Justice is pleased to establish a Cell headed by learned Member Inspection Team-II of this Court for redressal of below-mentioned grievances of the over-seas Pakistanis with immediate effect in the public interest on the following terms :-


1. The grievances sent by the over-seas Pakistanis through e-mail/fax/post pertaining to
 - a. Fraud
 - b. Delay in trial of cases pending before the Courts.
 - c. Family Problems/legal issues pending in Courts.
 - d. Illegal possession/dispossession qua property.
2. Disposal of cases of over-seas Pakistanis pending in Courts of law

1. The Director I.T. of this Court will assist the cell by furnishing printed copies of e-mails pertaining to the grievances of over-seas Pakistanis to the MIT-II through Assistant Registrar Inspection of this Court.
2. The MIT-II will forward the letters received by way of fax/post or e-mails to the District & Sessions Judges concerned for disposal under Human Rights, in accordance with law. The applications so forwarded to the District & Sessions Judges shall be disposed of within fifteen working days and the report regarding disposal and its fate will be furnished to MIT-II for perusal of the Honourable Chief Justice.
3. The Assistant Registrars of all the Judicial Branches of this Court, bench at Sukkur and Circuit Courts Larkana and Hyderabad are directed to identify the cases pertaining to the over-seas Pakistanis and furnish its detail to the MIT-II. All such cases should be enclosed in folder/file cover of Navy Blue color.
4. The cases pertaining to the over-seas Pakistanis shall be proceeded on priority basis so that such cases may not suffer unnecessary delay and shall be disposed of expeditiously.
