SUBMISSION GUIDELINES

1. The submission must not be previously published or currently under review at any other Journal/Conference/Book etc. and should not be submitted to any other Journal/Conference while in process of review with us. Read this point carefully; kindly do not submit the same paper at many places.
2. The submission must be the original work of the author(s), i.e. shouldn't be plagiarized or AI generated. It should be free from grammatical, spelling and other errors and also not contain any defamatory words.
3. Submission must be accompanied by an abstract of 75 to 150 words and author(s) affiliation. No Paper will be accepted without an abstract.
4. We prefer American Psychological Association (7th APA) referencing style. For other details visit FLJ website www.flj.gov.pk
5. Co-authorship is permitted to a maximum of 3 authors.
6. Federal Law Journal holds copyright over all contents published on its website. Any unauthorized use of the contents would be considered as a violation of copyright.
7. All submissions must be made in doc format. Documents in PDF format shall not be entertained.
 - The contributions may be made under the following categories; the word limit is exclusive of footnotes:
 - Research Paper: 4000-8000 words • Book Reviews: 2000-3000 words • Case Comment: 1500 – 2500 words

1. Submissions will only be accepted through OJS.
2. For submissions visit FLJ website www.flj.gov.pk and click "Submit Paper" and login or register. Please also go through checklist provided on the above link.

SUBMISSION POLICY
