

**THE HIGH COURT OF SINDH KARACHI**

**O R D E R**

**WHEREAS**, the Show Cause Notice bearing No.451/Conf:VI-Z-23(422) dated 13.04.2016 under the provisions of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973 was served upon Mr. Aijaz Ali Khaskheli, District & Sessions Judge on the ground of "**misconduct**" and reply thereof was furnished by him.

**AND WHEREAS**, the Authorised Officer after affording an opportunity of personal hearing to the delinquent officer and perusing the record, had come to the conclusion that delinquent officer is guilty of charges of '**misconduct**' leveled against him and liable to impose the major penalty as prescribed in Rule 4(1)(b)(iv) of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973. As such, a Final Show Cause Notice bearing No.755/Conf: VI-Z-23(422)P.F dated 27.7.2016 was served upon him and reply thereof was furnished by him.

**AND WHEREAS**, the Hon'ble Authorised Officer, after considering the reply to Final Show Cause Notice, affording an opportunity of personal hearing to the delinquent officer and going through the facts of the matter, has come to the conclusion that he is guilty of the charges leveled against him and recommended for imposition of major penalty of '**dismissal from service**', prescribed in Rule 4(1)(b)(iv) of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973, upon him.

**AND WHEREAS**, the Hon'ble Chief Justice/Authority has been pleased to provide an opportunity of personal hearing to the delinquent officer in respect of Final Show Cause Notice bearing No.1152/Conf:VI-Z-23(422)P.F dated 21.10.2016 but he opted to remain absent, hence His Lordship after considering the reply to Final Show Cause Notice, facts of the matter and scrutinizing the entire case, in exercise of the powers under Rule 5(4)(b) of the Sindh Civil Servants (Efficiency & Discipline) Rules 1973, has decided to impose major penalty of '**dismissal from service**' upon him.
