5. Commercial Cases will be given priority over the other matters.
6. Cases of Special Appellate Court (Custom & Taxation) will be fixed before Hon'ble Mr. Justice Salahuddin Panhwar.
7. Cause list of D.B-III, D.B-VII, S.B-III(A.S), S.B-IV(O.S) and S.B-V(O.S) has been issued for the entire week and adjustment of date through application in writing will be acceptable within three days after that no adjustment of any type will be allowed in the cases of above Benches.
