

## **HIGH COURT OF SINDH AT KARACHI.**

### **SUBMITTED:**

It is respectfully submitted that according to current roster of sitting w.e.f. 12.10.2020 to 07.11.2020, D.B-VI has been constituted comprising Hon'ble Mr. Justice Muhammad Junaid Ghaffar and Hon'ble Mr. Justice Agha Faisal except Monday/s and on Monday/s Hon'ble Mr. Justice Muhammad Junaid Ghaffar has been nominated to hold court sitting in S.B. (O.S.) while Hon'ble Mr. Justice Agha Faisal in S.B. (A.S.).

In said D.B-VI comprising Hon'ble Mr. Justice Muhammad Junaid Ghaffar and Hon'ble Mr. Justice Agha Faisal, following work has been assigned;

All C.Ps' relating to `CDGK, KW&SB Cantonment Boards, BOR, M.E.O, KDA, SBCA, KPT, KMC, K-Electric, NEPRA, Utility matters, Environmental Issues / litigations, Co-operative Societies and encroachment matters. All motion and regular hearing matters pertaining to Custom. All tax matters in which stay/status quo or restraining order is operating for more than 06 (six) months.

In view of the above, following order(s) are respectfully solicited to off-load the heavy burden of Custom and Tax matters:

- A: Whether Hon'ble Mr. Justice Muhammad Junaid Ghaffar and Hon'ble Mr. Justice Agha Faisal may be allowed to be exempted from holding court sitting in S.B. (O.S.) and S.B. (A.S.) respectively on Monday/s w.e.f. 12.10.2020 to 07.11.2020 and Date by court cases already fixed before their Lordships' on Monday 12.10.2020 may be allowed to be distributed amongst the Hon'ble Judges accordingly and rest of the board may be allowed to be discharged.

AND

- B: D.B-VI comprising Hon'ble Mr. Justice Muhammad Junaid Ghaffar and Hon'ble Mr. Justice Agha Faisal may be allowed to be constituted on Monday/s as well w.e.f. 12.10.2020 to 07.11.2020 and assigned specifically following work;


All motion and regular hearing matters pertaining to Custom. All tax matters in which stay/status quo or restraining order is operating for more than 06 (six) months.

and on Monday 12.10.2020 said cases may be allowed to be fixed in Additional Cause List as the main Cause List has already been published, and other than Monday/s said D.B-VI will function as per given complete assignments in current roster of sitting.


