- 1) All cases falling under sub paragraph (i) of Paragraph (a) and Paragraph (c) of clause (1) of Article 199 of the Constitution of Islamic Republic of Pakistan shall be heard by respective constitutional benches.
- 2) a) Cases which cannot be fixed before D.B-I will be fixed before D.B-III and vice versa and cases which cannot be fixed before DB-I and DB-III will be fixed before DB-II.
b) Cases which cannot be fixed before DB-II will be fixed before D.B-V and vice versa and cases which cannot be fixed before DB-II and DB-V will be fixed before D.B-III.
c) Cases which cannot be fixed before D.B-IV will be fixed before DB-V and cases which cannot be fixed before DB-IV and DB-V will be fixed before DB-II.
- 3) a) Cases which cannot be fixed before SB-I will be fixed before SB-VI and vice versa and cases which cannot be fixed before SB-I and SB-VI will be fixed before SB-IV.
b) Cases which cannot be fixed before SB-II will be fixed before SB-III and vice versa.
c) Cases which cannot be fixed before SB-IV will be fixed before SB-V and vice versa and cases which cannot be fixed before SB-IV and SB-V will be fixed before SB-VI.
- 4) Cases for contempt of Court received from the subordinate courts and matters relating to transfer of Anti-Terrorism cases outside Karachi will be fixed on Monday(s) as per the directions of Hon'ble Chief Justice.
- 5) Commercial Cases will be given priority over the other matters.
- 6) Any matter in which Learned Registrar or Learned MIT(s) of High Court of Sindh is a party, will be fixed before the Divisional Bench as per directions of Hon'ble Chief Justice.
- 7) In case for any reason, the case (s) which cannot be fixed before any D.B. and/or any S.B. the matter will be placed before the Hon'ble Chief Justice for appropriate order(s).
