c) Cases which cannot be fixed before D.B-IV will be fixed before D.B-II.
- 2) a) Cases which cannot be fixed before S.B-I will be fixed before S.B-II and vice versa and cases which cannot be fixed before S.B-I & S.B-II will be fixed before S.B-III.  
b) Cases which cannot be fixed before S.B-III will be fixed before S.B-IV and vice versa and cases which cannot be fixed before S.B-III and S.B-IV will be fixed before S.B-V.  
c) Cases which cannot be fixed before S.B-V will be fixed before S.B-VI and vice versa and cases which cannot be fixed before S.B-V and S.B-VI will be fixed before S.B-IV.  
d) Cases which cannot be fixed before Honourable Judge(s) nominated to hear Company Matters will be fixed before other Honourable Judge(s) having same assignment.
- 3) Cases for contempt of Court received from the subordinate courts and matters relating to transfer of Anti-Terrorism cases outside Karachi will be fixed on Monday(s) as per the directions of Hon'ble Chief Justice.
- 4) Commercial Cases will be given priority over the other matters.
- 5) **Any matter in which learned Registrar or learned MIT(s) of High Court of Sindh is a party, will be fixed before the Divisional Bench as per directions of Hon'ble Chief Justice.**
- 6) In case for any reason, the case (s) which cannot be fixed before any D.B. and/or any S.B. the matter will be placed before the Hon'ble Chief Justice for appropriate order(s).
