Cases which cannot be fixed before D.B-II will be fixed before D.B-III, and vice versa and Cases which cannot be fixed before D.B-II and D.B-III will be fixed before D.B-IV. Cases which cannot be fixed before D.B-IV, will be fixed before D.B-V, and vice versa and Cases which cannot be fixed before D.B-IV and D.B-V will be fixed before D.B-I.
- 2) Urgent cases/applications of each category on the Original Civil Side will be fixed before the concerned Bench who has been assigned the subject roster sifting. Cases which cannot be fixed before SB-I (A.S) will be fixed before SB-IV (A.S) and vice versa and cases which cannot be fixed before SB-I (AS) and SB-IV (A.S) will be fixed before SB-III (A.S). Cases which cannot be fixed before SB-II (A.S) will be fixed before SB-III (A.S), and vice versa and cases which cannot be fixed before SB-II (A.S) and SB-III (A.S) will be fixed before SB-IV (A.S). Cases which cannot be fixed before S.B-II (O.S) will be fixed before SB-III (O.S) and vice versa, and Cases which cannot be fixed before SB-II (O.S) and SB-III (O.S), will be fixed before SB-I (O.S).
- 3) Cases which cannot be fixed before the Hon'ble Judges sitting at Appellate Side will be fixed sequentially before senior most Judge of Original Side. Similarly cases which cannot be fixed before the Hon'ble Judges sitting at Original Side will be fixed sequentially before senior most Judge of Appellate Side.
- 4) Cases for contempt of Court received from the subordinate courts and matters relating to transfer of Anti-Terrorism cases will be fixed on Monday(s) as per the directions of Hon'ble Chief Justice.

- 5) Commercial Cases will be given priority over the other matters.
- 6) Any matter in which Learned Registrar or Learned MIT(s) of High Court of Sindh is a party, will be fixed before the Divisional Bench as per directions of Hon'ble Chief Justice.
- 7) In case for any reason, the case (s) which cannot be fixed before any D.B, the matter will be placed before the Hon'ble Chief Justice for appropriate order(s).
