For orders and hearing of applications in all suits relating to financial obligations/tax etc., priority be given to those matters in which status quo or restraining order is operating,

- i) Awards,
- ii) Succession,
- iii) Intellectual property,
- iv) Tax and financial obligation matters including final arguments and
- v) All matters not notified in any of the above O.S. roster.

Note: Hon'ble Mr. Justice Adnan Iqbal Chaudhry shall also hear all matters related to Special Appellate Court (Customs & Taxation) AND in case such case cannot be fixed before his lordship then the same shall be fixed before Hon'ble Mr. Justice Agha Faisal being Special Appellate Court (Customs & Taxation)

**NOTE:** Mr. Justice Omar Sial (Abroad from 01-12-2024 to 10-12-2024)

- 1) **All cases falling under sub paragraph (i) of Paragraph (a) and Paragraph (c) of clause (1) of Article 199 of the Constitution of Islamic Republic of Pakistan shall be heard by respective constitutional benches.**
- 2) Cases which cannot be fixed before D.B-I, will be fixed before D.B-III and Cases which cannot be fixed before D.B-I and D.B-III will be fixed before D.B-II. Cases which cannot be fixed before D.B-II will be fixed before D.B-III, and vice versa and Cases which cannot be fixed before D.B-II and D.B-III will be fixed before D.B-I.
- 3) Urgent cases/applications of each category on the Original Civil Side will be fixed before the concerned Bench who has been assigned the subject roster sitting. Cases which cannot be fixed before SB-I (A.S) will be fixed before SB-II (A.S) and vice versa. Cases which cannot be fixed before S.B-I (A.S) and SB-II (A.S) will be fixed before S.B-III (A.S) and cases which cannot be fixed before S.B-III (A.S) will be fixed before S.B-I (A.S) Similarly Cases which cannot be fixed before SB-I (O.S) will be fixed before SB-II (O.S) and vice versa and cases which cannot be fixed before S.B-I (O.S) and S.B-II (O.S) will be fixed before S.B-III (O.S). Cases which cannot be fixed before S.B-III (O.S) will be fixed before SB-I (O.S).
- 4) Cases which cannot be fixed before the Hon'ble Judges sitting at Appellate Side will be fixed sequentially before senior most Judge of Original Side. Similarly cases which cannot be fixed before the Hon'ble Judges sitting at Original Side will be fixed sequentially before senior most Judge of Appellate Side.
- 5) Cases for contempt of Court received from the subordinate courts and matters relating to transfer of Anti-Terrorism cases outside Karachi will be fixed on Monday(s) as per the directions of Hon'ble Chief Justice.
- 6) Commercial Cases will be given priority over the other matters.
- 7) Any matter in which Learned Registrar or Learned MIT(s) of High Court of Sindh is a party (excluding the constitution bench cases as identified at Para-1 above), will be fixed before the Divisional Bench as per directions of Hon'ble Chief Justice.



- 8) In case for any reason, the case (s) which cannot be fixed before any D.B, the matter will be placed before the Hon'ble Chief Justice for appropriate order(s).
