- Cases which cannot be fixed before D.B-I, will be fixed before D.B-II, and vice versa and Cases which cannot be fixed before D.B-I and D.B-II will be fixed before D.B-III. Cases which cannot be fixed before D.B-III will be fixed before D.B-V. and vice versa and Cases which cannot be fixed before D.B-III and D.B-V will be fixed before D.B-II. Cases which cannot be fixed before D.B-IV, will be fixed before D.B-VI, and vice versa and Cases which cannot be fixed before D.B-IV and D.B-VI will be fixed before D.B-V.
- Urgent cases on the Original Civil Side will be fixed before the Senior Judge holding Court Sitting on Original Civil Side (O.S-I). Cases which cannot be fixed before (O.S-I) will be fixed before (O.S-III) and vice versa and cases which cannot be fixed before (O.S-I) and (O.S-III) will be fixed before (O.S-V). Cases which cannot be fixed before (O.S-II) will be fixed before (O.S-III), cases of (OS-II) which cannot be fixed before (O.S-III) will be fixed before (O.S-V). Cases which cannot be fixed before (O.S-IV) will be fixed before (O.S-V) and vice versa and cases which cannot be fixed before (O.S-IV) and (O.S-V) will be fixed before (O.S-III). Similarly Cases which cannot be fixed before SB-I (A.S) will be fixed before SB-III (A.S) and vice versa and Cases which cannot be fixed before S.B-I (A.S) and S.B-III (A.S), will be fixed before S.B-II (A.S). Cases which cannot be fixed before S.B-II (A.S) will be fixed before SB-IV (A.S) and vice versa, and Cases which cannot be fixed before SB-II (A.S) and SB-IV (A.S), will be fixed before SB-III (A.S). Cases which cannot be fixed before S.B-V (A.S) will be fixed before S.B-II and Cases of S.B-V (A.S), which cannot be fixed before S.B-II (A.S), will be fixed before S.B-IV (A.S).
- 3) Cases which cannot be fixed before the Hon'ble Judges sitting at Appellate Side will be fixed before senior most Judge of Original Side. Similarly cases which cannot be fixed before the Hon'ble Judges sitting at Original Side will be fixed before senior most Judge of Appellate Side
