- 9) a) Cases which cannot be fixed before D.B-I will be fixed before D.B-III and vice versa and cases which cannot be fixed before DB-I and DB-III will be fixed before DB-II.  
b) Cases which cannot be fixed before DB-II will be fixed before D.B-IV and vice versa and cases which cannot be fixed before DB-II and DB-IV will be fixed before D.B-III.  
c) Cases which cannot be fixed before D.B-IV will be fixed before DB-III and cases which cannot be fixed before DB-IV and DB-III will be fixed before DB-II.
- 10) a) Cases which cannot be fixed before SB-I will be fixed before SB-V and vice versa and cases which cannot be fixed before SB-I and SB-V will be fixed before SB-VI.  
b) Cases which cannot be fixed before SB-II will be fixed before SB-VII and vice versa and cases which can not be fixed before SB-II and VII will be fixed before S.B-VI.  
c) Cases which cannot be fixed before S.B-VI will be fixed before S.B-VII.
- 11) Cases for contempt of Court received from the subordinate courts and matters relating to transfer of Anti-Terrorism cases outside Karachi will be fixed on Monday(s) as per the directions of Hon'ble Acting Chief Justice.
- 12) Commercial Cases will be given priority over the other matters.
- 13) Any matter in which Learned Registrar or Learned MIT(s) of High Court of Sindh is a party, will be fixed before the Divisional Bench as per directions of Hon'ble Acting Chief Justice.
- 14) In case for any reason, the case (s) which cannot be fixed before any D.B. and/or any S.B. the matter will be placed before the Hon'ble Acting Chief Justice for appropriate order(s).
