- 3) Urgent cases/applications of each category on the Original Civil Side will be fixed before the concerned Bench who has been assigned the subject roster sitting. Cases which cannot be fixed before SB-I (A.S) will be fixed before SB-III (A.S) and vice versa and cases which cannot be fixed before SB-I (AS) and SB-III (A.S) will be fixed before SB-II (A.S).
