S B-IV (O.S.) MR. JUSTICE ADNAN IQBAL CHAUDHRY

All cases of issues /examination of parties, recording of evidence, arguments and final disposal

Note: Hon'ble Mr. Justice Adnan Iqbal Chaudhry shall also hear all matters relating to Special Appellate Court (Customs & Taxation)

NOTE:

- 1) Cases which cannot be fixed before D.B-I, will be fixed before D B-V, and vice versa and Cases which cannot be fixed before D.B-I and D.B-V will be fixed before D B-III. Cases which cannot be fixed before D B-II will be fixed before D B-III, and vice versa and Cases which cannot be fixed before D B-II and D B-III will be fixed before D B-I. Cases which cannot be fixed before D.B-IV, will be fixed before D B-VI, and vice versa and Cases which cannot be fixed before D B-IV and D B-VI will be fixed before D B-V.
- 2) Urgent cases on the Original Civil Side will be fixed before the Senior Judge holding Court Sitting on Original Civil Side (O.S-I). Cases which cannot be fixed before (O.S-I) will be fixed before (O S-II) and vice versa and cases which cannot be fixed before (O S-I) and (O S-II) will be fixed before (O S-III). Cases which cannot be fixed before (O S-III) will be fixed before (O S-IV), and vice versa and cases which cannot be fixed before (O S-III) and (O S-IV) will be fixed before (O S-II). Similarly Cases which cannot be fixed before SB-I (A S) will be fixed before SB-II (A S) and vice versa and Cases which cannot be fixed before S B-I (A.S) and S B-II (A S), will be fixed before S B-III (A S) Cases which cannot be fixed before S.B-III (A.S) will be fixed before SB-IV (A.S) and vice versa, and Cases which cannot be fixed before SB-III (A.S) and SB-IV (A.S), will be fixed before SB-II (A S). Cases which cannot be fixed before S B-V (A S) will be fixed before S B-III and Cases of S B-V (A.S), which cannot be fixed before S B-III (A S), will be fixed before S B-IV (A S).
- 3) Cases which cannot be fixed before the Hon'ble Judges sitting at Appellate Side will be fixed before senior most Judge of Original Side. Similarly cases which cannot be fixed before the Hon'ble Judges sitting at Original Side will be fixed before senior most Judge of Appellate Side.
- 4) Cases under various acts, contempt of Court cases received from the subordinate courts, Bail before arrest and matters relating to transfer of cases will be fixed on Monday(s) as per the directions of Hon'ble Chief Justice.
- 5) Commercial Cases will be given priority over the other matters.
- 6) Any matter in which Learned Registrar or Learned MIT(s) of High Court of Sindh is a party, such cases will be fixed before the Divisional Bench as per directions of Hon'ble Chief Justice.
- 7) In case for any reason, the case (s) which cannot be fixed before any D.B, the matter will be placed before the Hon'ble Chief Justice for appropriate order(s).
- 8) All Permissions in the Cases may be obtained in pursuance of Circular No.GAZ/XII.Z.14(HC)(iii) Karachi dated 21.08.2021.
