1. Cases which cannot be fixed before D.B-I will be fixed before D.B-IV and vice versa and cases which cannot be fixed before D.B-I & DB-IV will be fixed before of DB-III, Cases which cannot be fixed before D.B-II will be fixed before D.B-III and vice versa and cases which cannot be fixed before D.B-II & DB-III will be fixed before DB-IV.
2. Cases under various Act; Contempt of Court cases received from the Subordinate Courts, Bail before arrest and matters relating to transfer of cases will be fixed before the Hon'ble Chief Justice or any other Hon'ble Judge to whom the Hon'ble Chief Justice, nominates.
3. Cases which cannot be fixed before (OS-I) will be fixed before (OS-III) and vice versa, Cases which cannot be fixed before (OS-II) will be fixed before (OS-I) and cases of (OS-II) which cannot be fixed before (OS-I) will be fixed before (OS-III). Similarly Cases which cannot be fixed before SB-I (AS) will be fixed before SB-II (AS) and vice versa, and Cases which cannot be fixed before S.B-I (AS) and S.B-II (AS) will be fixed before S.B-III (AS). Cases which cannot be fixed before SB-III (AS) will be fixed before SB-IV (AS) and vice versa, and Cases which cannot be fixed before S.B-III (AS) and S.B-IV (AS) will be fixed before S.B-I (AS).
4. Cases which cannot be fixed before the Hon'ble Judges sitting at appellate side will be fixed before senior most Judge of original side. Similarly cases which cannot be fixed before the Hon'ble Judges sitting at original side will be fixed before senior most Judge of appellate side.
5. Any matter in which Learned Registrar or Learned MIT(s) of High Court of Sindh is a party, such cases will be fixed before the Divisional Bench to be headed by the Honourable Chief Justice, as well as any case / matter which Honourable Chief Justice desires to hear that will be fixed before the Honourable Chief Justice.
6. Commercial Cases will be given priority over the other matters.
7. Cases of Special Appellate Court (Custom & Taxation) will be fixed before the Senior most Judge of SB Appellate Side.
8. Cases / matters on Appellate Side (SB) in which urgent permission is required to be sought other than Monday/s may be obtained / granted by Honourable Senior Judge sitting on Appellate Side (SB) as "J-1" except matters pertain to the jurisdiction of Honourable Chief Justice.
