- 4) Cases under various acts, contempt of Court cases received from the subordinate courts, Bail before arrest and matters relating to transfer of cases will be fixed on Monday(s) as per the directions of Hon'ble Chief Justice.
- Commercial Cases will be given priority over the other matters
- 6) Any matter in which Learned Registrar or Learned MIT(s) of High Court of Sindh is a party, such cases will be fixed before the Divisional Bench as per directions of Hon'ble Chief Justice.
- 7) In case for any reason, the case (s) which cannot be fixed before any D.B. the matter will be placed before the Hon'ble Chief Justice for appropriate order(s).
