**Note:**

1. Cases which cannot be fixed before DB-I, will be fixed before DB-II and vice versa and cases which cannot not be fixed before DB-I and DB-II will be fixed before DB-III, cases which cannot be fixed before DB-III will be fixed before DB-I and cases of DB-III which cannot be fixed before DB-I will be fixed before DB-II.
2. **(First Portion):-** Cases which cannot be fixed before SB-I(AS) will be fixed before SB-II(AS), and vice versa and cases which cannot not be fixed before SB-I(AS) and SB-II(AS) will be fixed before SB-III(AS), cases which cannot be fixed before SB-III(AS) will be fixed before SB-I(AS) and cases of SB-III(AS) which cannot be fixed before SB-I(AS) will be fixed before SB-II(AS). Similarly Cases which cannot be fixed before SB-I (OS) will be fixed before SB-II (OS) and cases of SB-I (OS) which cannot be fixed before SB-II (OS) will be fixed before SB-III (OS). Cases which cannot be fixed before SB-II (OS) will be fixed before SB-III (OS), and vice versa.
3. **(Second Portion):-** Cases which cannot be fixed before SB-I (AS) will be fixed before SB-II (AS), and vice versa and cases which cannot not be fixed before SB-I(AS) and SB-II(AS) will be fixed before SB-III(AS). Cases which cannot be fixed before SB-III(AS), will be fixed before SB-IV(AS) and vice versa and cases which cannot not be fixed before SB-III(AS) and SB-IV(AS) will be fixed before SB-I(AS). Similarly Cases which cannot be fixed before SB-I (OS) will be fixed before SB-II (OS) and vice versa.
4. Case under various Act. Contempt of Court cases received from the Sub-Ordinate Courts. Application for early hearing of cases. Bail before arrest applications and matters relating to transfer of cases will be fixed before the Honourable Chief Justice and in his lordship's absence at principal seat Karachi will be fixed before another Senior most Judge.
5. Cases which cannot be fixed before all Original Side Judges will be fixed before Senior most Judge SB (AS), similarly cases which cannot be fixed before all (AS) Judges will be fixed before Senior most Judge SB (OS).
6. Commercial Cases will be given priority over other matters.
7. Cases of Special Appellate Court (Customs & Taxation) will be fixed before Honourable Mr Justice Shah Nawaz Tariq and in his lordship's absence will be fixed before Senior most Judge of SB (AS).
