O R D E R

WHEREAS, the Show Cause Notices bearing No.726/Conf:VI-Z-23(Reports), dated 31.7.2009 and No. 473/Conf:VI-Z-23(70)JM-DP, dated 17.6.2013 under the provisions of Sindh Civil Servants (Efficiency & Discipline) Rules, 1973 on the ground of 'corruption' were served upon Mr. Muhammad Jawaid Salman, Civil Judge & Judicial Magistrate, replies thereof was furnished by him on 19.10.2009 and 26.8.2013, respectively.

AND WHEREAS, the Authorised Officer after affording an opportunity of personal hearing to the delinquent Officer and perusing the record, had come to the conclusion that he is guilty of charge leveled against him and liable to impose one of the major penalties prescribed under Rule 4(1)(b) of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973, upon him. As such Final Show Cause Notice bearing No.410/Conf:VI-Z-23(70)JM-DP dated 2.5.2015 was served upon him and reply thereof was furnished by him on 8.6.2015.


AND WHEREAS, the Hon'ble Authorised Officer, while going through the facts as well as circumstances of the matter and giving an opportunity of personal hearing to the delinquent Officer, has come to the conclusion that he is guilty of the charge leveled against him and recommended that the major penalty of '**dismissal from service**' as prescribed under Rule 4(1)(b)(iv) of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973, be imposed upon him.

AND WHEREAS, the Hon'ble Chief Justice/Authority, after considering the facts as well as circumstances of the matter and hearing the delinquent Officer in person has decided, in exercise of powers under clause (b) of Sub-Rule (4) of Rule 5 of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973, to impose major penalty of '**dismissal from service**' as prescribed under Rule 4(1)(b)(iv) of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973, upon Mr. Muhammad Jawaid Salman, Civil Judge & Judicial Magistrate.

NOW THEREFORE, the penalty of 'dismissal from service' as prescribed under Rule 4(1)(b)(iv) of the Sindh Civil Servants (Efficiency & Discipline) Rules, 1973 is hereby imposed on Mr. Muhammad Jawaid Salman, Civil Judge & Judicial Magistrate, with immediate effect.


